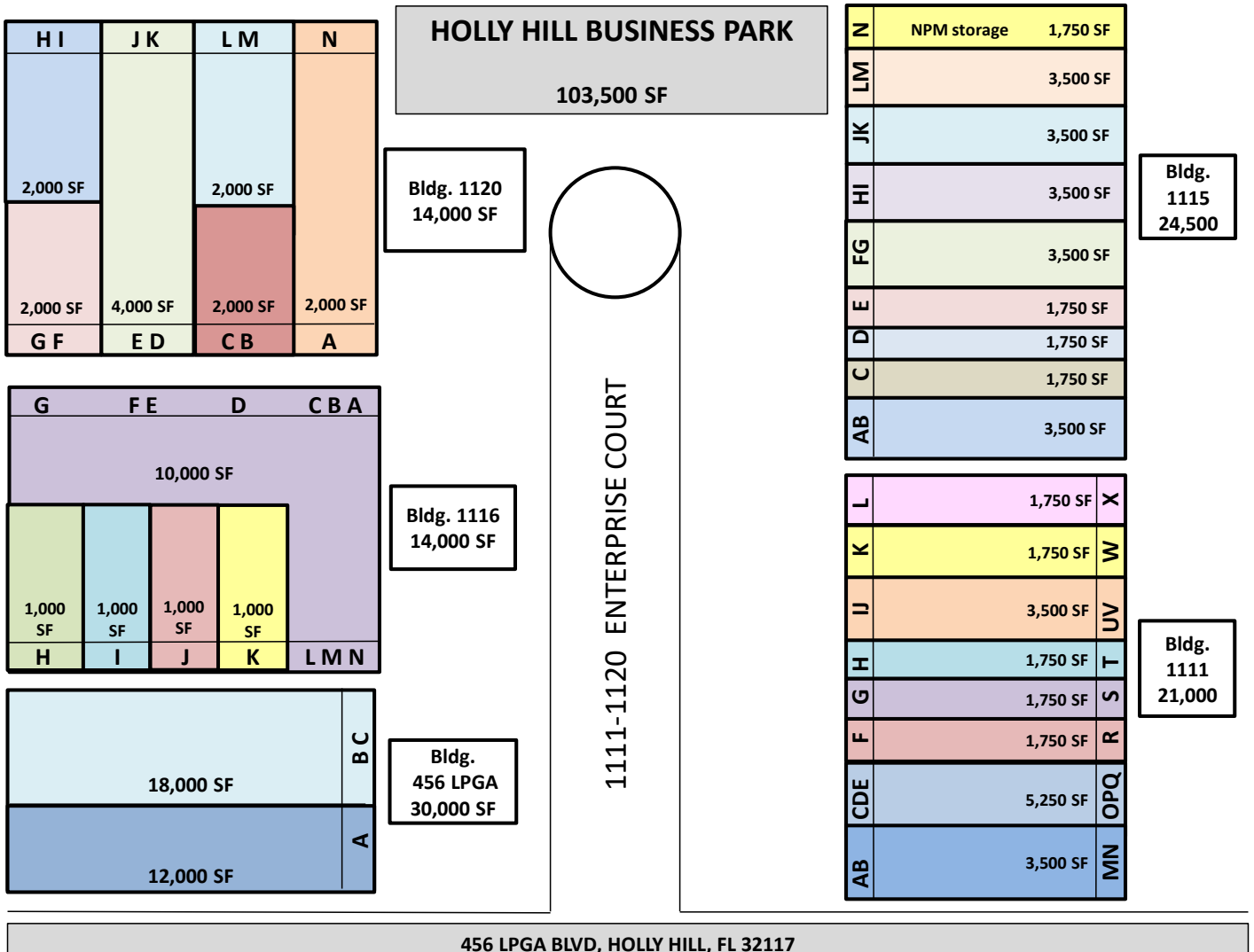

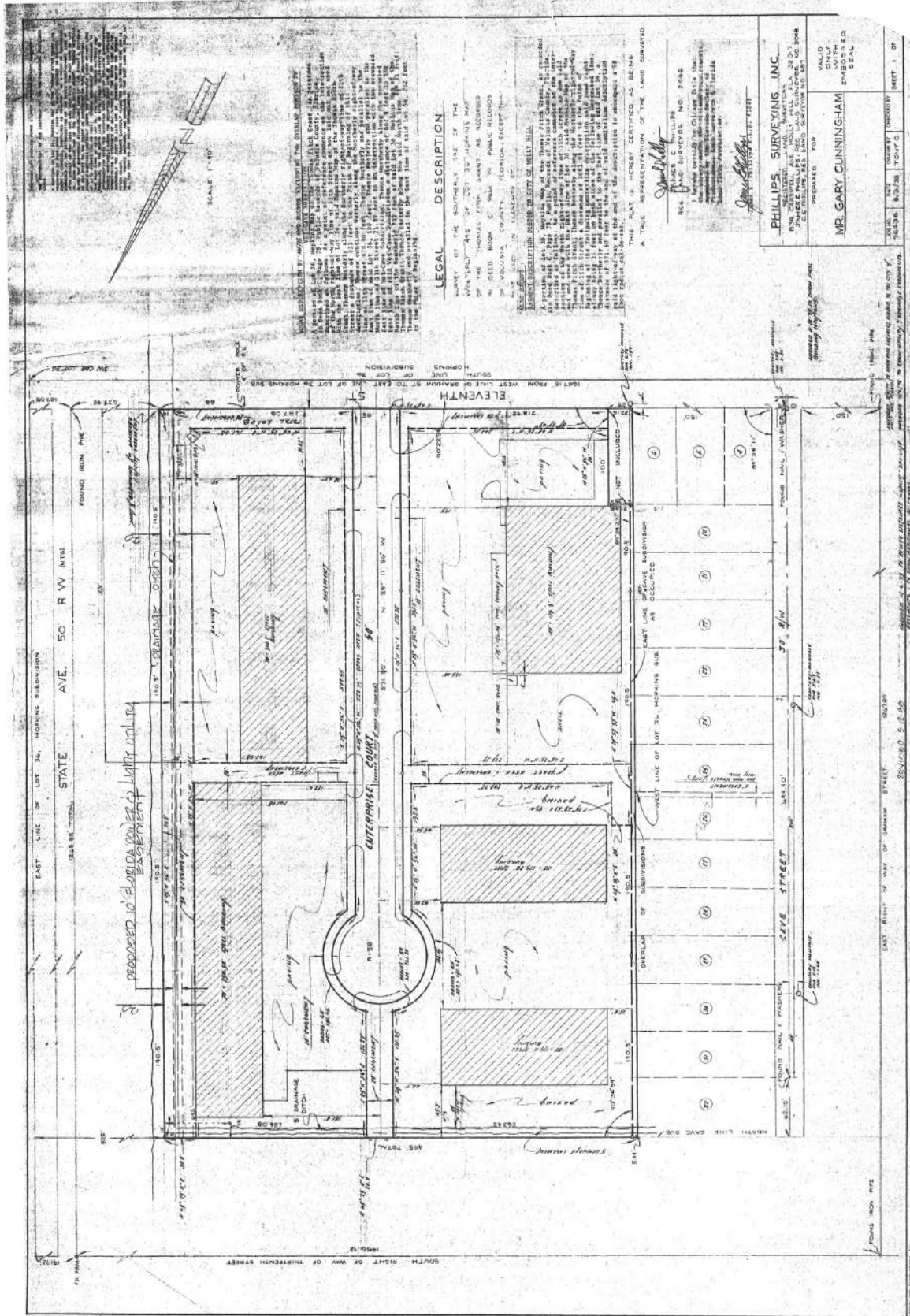


PARK LAYOUT

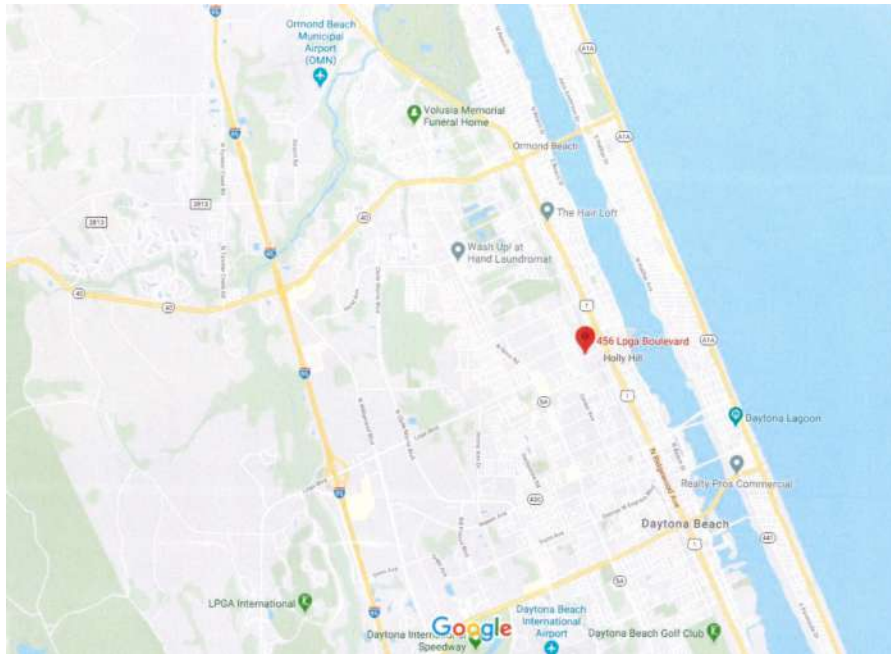
